She is the founder, speech-language pathologist, and coordinator of a public school program for preschool and elementary children who present with significant special needs in the areas of communicative, cognitive, social, behavioral and motor disabilities. These students have been using PECS to improve functional communication skills while they take part in a classroom that has been implementing the Pyramid Approach to Education. Jo-Anne has presented extensively at various conferences and workshops to parents and professionals in the areas of speech-language development, functional communication, and program design. She is also an active member of the American Speech-Language-Hearing Association.
