About the Presenter

Autism and the School Resource Officer training course is instructed by Bart Barta. Bart is the proud father of Daniel, a teenager with autism. Bart understands many of the challenges faced by individuals and families affected by autism spectrum disorder. Bart is a retired law enforcement commander who has trained more than 8,000 first responders how to successfully interact with people on the autism spectrum. autism spectrum. Bart is recognized as a subject matter expert by The Florida Department of Law Enforcement (FDLE) and in 2017 was selected to contribute to the development of autism curriculum for officers in the state of Florida. For more than 10 years, Bart served as an instructor for the Crisis Intervention Team (CIT) Training Program for Florida's Eleventh Circuit Court's Mental Health Project. Bart is a former SWAT and Crisis Management Team (Hostage Negotiations) Commander. Bart is the former Commander of the Coral Gables Police Department's Criminal Investigations Division, where he was responsible for the investigation of all violent and non-violent crime. For six years, Bart served as a member of the University of Miami-Nova Southeastern University's Center for Autism and Related Disabilities (CARD) Constituency Board.

Training Description

Target Audience: This is a closed training for officers and security personnel who work in the school district

This course will provide school resource officers and school security personnel with a basic understanding of autism spectrum disorder (ASD) and how students with autism behave, communicate, and react in various situations. Furthermore, it will address high-risk and crisis incidents and provide officers with tips and strategies to defuse and deescalate the situation. The topics that are covered in this training include: Typical law enforcement tactics, Crisis intervention techniques, Interview techniques, Wes Kleinert Fair Interview Act-F.s. 394, Missing persons, elopement, and wandering, Arrest, restraint and seclusion, De-escalation techniques, Tools of disclosure, and Available resources.

Training Objectives

Participants will be able to:

- Understand what autism is and how students are affected by it.
- Recognize possible signs of autism.
- Understand how autism affects students differently.
- Develop alternative ways of identifying students with autism.
- Understand the various challenges of interviewing students with autism.
- Develop strategies for reducing stress and anxiety in students with autism.
- Develop de-escalation techniques for responding to autistic students in crisis.
- Understand what types of crimes and schemes that students with autism are more likely to become victims of.
- Recognize when an involuntary mental health examination is necessary.
- Understand best practices for responding to students with autism who elope or are discovered missing while in school.
