About the Presenters

Dr. Bill Ahearn is the director of research at the New England Center for Children. He has published extensively on behavior analytic interventions for treating problem behavior and teaching social and communicative behavior. He was named the 2009 APA Div. 25 awardee for Enduring Contributions to Applied Behavioral Research. Dr. Ahern is the chair of the board that licenses behavior analysts in Massachusetts and serves as the editor-in-chief for *Behavioral Interventions*.

Dr. Gregory P. Hanley is currently a professor of psychology, director of the Behavior Analysis Doctoral Program at Western New England University, and an adjunct professor of psychiatry at the University of Massachusetts Medical School. He has published extensively on the assessment, treatment, and prevention of problem behavior and evidence-based values; is a fellow of APA's Div. 25, and serves as the editor of the *Journal of Applied Behavior Analysis*.

This workshop will provide participants best practices from the field of behavior analysis to promote independence, teach social skills, and address problem behaviors.

Training Objectives

Participants will be able to discuss and describe:

- Strategies for teaching chains of behavior and for training social skills.
- Critical aspects of the response interruption and redirection procedure.
- The conditions under which the different types of functional assessment should and should not be used when attempting to understand why problem behavior is occurring.
- The functional assessment process, which involves open-ended interview and test-control analysis, and how this process can be used to develop fast, safe, and effective outcomes for students.
